

**ORDINANCE NO. 2020.06-14**

**AN ORDINANCE AMENDING SECTIONS 272-1 A. (2) and 272-1 A. (4) OF THE SALEM LAKES MUNICIPAL CODE REGARDING INTOXICATING LIQUOR LICENSE FEES.**

The Village Board of the Village of Salem Lakes, Kenosha County, Wisconsin, does hereby ordain as follows:

**SECTION 1.**            Purpose. The purpose of this ordinance is to amend sections 272-1 A. (2) and 272-1 A. (4) of the Salem Lakes Municipal Code regarding "Class A" and "Class B" intoxicating liquor license fees in light of state orders limiting business operations due to the effects of the Covid-19 virus.

**SECTION 2.**            Section 272-1 A. (2) Amended. Section 272-1 A. (2) of the Salem Lakes Municipal Code regarding intoxicating liquor license fees is amended to provide as follows:

(2) "Class A" intoxicating liquor license: \$500 per year, provided, however, that the license fee for the 2020-2021 license year shall be \$375 payable as follows: \$100 upon issuance and the balance of \$275 payable in monthly installments of \$45.84 payable on or before the last day of each month beginning July 31, 2020. For the 2020-2021 license year, failure to pay any installment payment on or before the scheduled due date shall constitute grounds for license revocation.

**SECTION 3.**            Section 272-1 A. (4) Amended. Section 272-1 A. (4) of the Salem Lakes Municipal Code regarding intoxicating liquor license fees is amended to provide as follows:

(2) "Retail "Class B" intoxicating liquor license: \$500; provided, however, that any such license granted or issued on or after December 1, 1997, for premises not possessing a license on December 1, 1997, shall be charged an additional fee of \$10,000. Renewals of existing licenses issued after December 1, 1997, shall be charged the renewal fee of \$500. Notwithstanding the foregoing, the license fee for the 2020-2021 license year (excluding licenses granted or issued on or after December 1, 1997, for premises not possessing a license on December 1, 1997) shall be \$375 payable as follows: \$100 upon issuance and the balance of \$275 payable in monthly installments of \$45.84 payable on or before the last day of each month beginning July 31, 2020. For the 2020-2021 license year, failure to pay any installment payment on or before the scheduled due date shall constitute grounds for license revocation.

**SECTION 4.**            Severability. Each section, subsection, paragraph, sentence, clause, phrase and provision of the foregoing ordinance is and the same is hereby declared to be severable and if any portion or provision thereof is duly determined to be invalid for any reason, such determination shall not invalidate any other portion or provision thereof.

**SECTION 5.**            Effective Date. This ordinance shall take effect and be enforced from and after publication and posting as required by law.
